1. Philosophy

Institute believes that:

Under graduate nursing education program prepares its graduates to become exemplary citizen by adhering to code of ethics and professional conduct at all times in fulfilling personal, social and professional obligations so as to respond to national aspirations.

It will bridge the gap between academic intellect and professional proficiencies by making the approach to education more analytical, thorough, job-oriented, skill-based and as per industry requirements. 2. <u>Aim</u>

The aim of the undergraduate nursing program is to:

- Prepare graduates to assume responsibilities as professional, competent nurses and midwives in providing promotive, preventive, curative, and rehabilitative services.
- Prepare nurses who can make independent decisions in nursing situations, protect the rights of and facilitate individuals and groups in pursuit of health, function in the hospital, community-nursing services and conduct

research studies in the areas of nursing practice. They are also expected to assume the role of teacher, supervisor and manager in a clinical/public health setting.

3. Objectives

On completion of the four-year B.Sc. Nursing program the graduate will be able to:

- 3.1. Apply knowledge from physical, biological and behavioral sciences, medicine including alternative systems and nursing in providing nursing care to individuals, families and communities.
- 3.2. Demonstrate understanding of life style and other factors, which affect health of individuals and groups.
- 3.3. Provide nursing care based on steps of nursing process in collaboration with the individuals and groups.
- 3.4. Demonstrate critical thinking skill in making decisions in all situations in order to provide quality care.
- 3.5. Utilize the latest trends and technology in providing health care.
- 3.6. Provide promotive, preventive and restorative health services in line with the National Health Policies and programmes.
- 3.7. Practice within the framework of code of ethics and professional conduct, and acceptable standards of practice within the legal boundaries.
- 3.8. Communicate effectively with individuals and groups, and members of the health team in order topromote effective interpersonal relationships and teamwork.
- 3.9. Demonstrate skills in teaching to individuals and groups in clinical/community health settings.
- 3.10. Participate effectively as members of the health team in health care delivery system.
- 3.11. Demonstrate leadership and managerial skills in clinical/community health settings.
- 3.12. Conduct need based research studies in various settings and utilize the research findings to improve the quality of care.
- 3.13. Demonstrate awareness, interest and contribute towards advancement of self and of the profession.
- 3.14. Demonstrate personal characteristics and attitudes (like personal integrity, responsibility, reliability and showing concern for other individuals) required for professional life.

4. Programme Outcome:

At the end of the course the B.Sc (N) Program the graduate nurse will be able to function as a 'Nurse' to provide comprehensive and quality care / supervise and train nursing students at various health care settings and educational institutions and adhere to the code of Nursing Ethics

Title of the Programme: Bachelor of Science in Nursing

5. <u>Regulations relating to B Sc. NURSING PROGRAMME</u>

Title and Commencement:

These regulations shall be called "THE REGULATIONS FOR THE **BACHELOR OF SCIENCE IN**

NURSING DEGREE PROGRAMME (B.Sc. in Nursing) OF BRAINWARE UNIVERSITY, Barasat, Kolkata.".

They shall come into force from the academic year 2020-2021 session. The regulation and syllabus are subject to modifications by the standing Under Graduate Board of Studies for nursing course from time to time maintaining the INC norms and regulations.

6. <u>Attendance</u>

- 6.1 A candidate must have a minimum of 80% attendance (irrespective of the kind of absence) in theory and practical separately in each subject to be eligible to appear for the University Examination.
- 6.2 However, the students should have 100% attendance in each of the practical areas before award of the degree.
- 6.3 <u>A regular candidate attending less than the required attendance in a year may be declared 'non-</u> <u>collegiate'. He / She may be allowed to appear at the concerned examination on valid reason after</u> <u>obtaining permission from Registrar or Vice Chancellor as a special case. Maximum of 5% may be</u> <u>condoned by the University on a genuine reason after considering all aspects including non-collegiate</u> <u>fees.</u>

6.4 However he /she may have to pay the requisite non-collegiate fees if required.

7. <u>Regulations related to Internal assessment</u>

- 7.1 Regular periodic assessment shall be conducted throughout the course. At least three Class tests / Unit Tests and Three Term Tests/ Term Examinations in theory and preferably two practical examinations should be conducted in each subject.
- 7.2 The model examination should be of the same pattern of the University Examination. Weightage of 60% to be considered from Class tests / Unit Tests and Three Term Tests/ Term Examinations and 40% weightage to be considered from assignments and presentation to calculate the internal assessment.
- 7.3 Marks of each assessment to be uploaded within 14 days of commencement of examination at the academic software, so that student can view their marks and the same can be used for future reference.
- 7.4 For practical related subjects, preferably atleast two practical examinations shall be conducted throughout the course. Weightage of 60% to be considered from practical examinations and 40% weightage to be considered from practical assignments to calculate the internal assessment.
- 7.5 A candidate should secure a minimum of 50% mark in the internal assessment in each subject (separately in theory and practical) to be eligible to appear for the University examination.
- 7.6 If the candidate fails to secure 50% in theory and practical separately in the Internal assessment then the candidate shall not be allowed to appear for final exam.

- 7.7 The candidate shall submit a record of the clinical work (clinical record book and practical file) done in that year duly attested by the Principal of Institute of Nursing.
- 7.8 <u>The students must submit the complete 'midwifery case record book' before appearing for the 4th year final examination. In case of failure, the students shall not be permitted to appear for the 4th year final exam.</u>
- 7.9 The internal assessment marks shall be submitted to the University 1 month prior to the Commencement of the University Examinations.
- 7.10. List of Presentation topic, Attendance and hard copy of presentation file has to be preserved by the respective department.

9. Examination Rules and Regulations

- 9.1 B.Sc. Nursing programme comprises of theory papers, practical papers etc.
- 9.2 At the end of each year there shall be a term-end-annual examination as per the schedule announced by the Controller of Examinations at least one month prior to the commencement of the examination.
- 9.3 The medium of examination shall be English.
- 9.4 Generally, the Annual examination will be conducted in the month of **September** of every year.
- 9.5 This schedule may be change whenever notified by the Controller of Examinations.
- 9.6 Each student has to submit duly filled in examination form online and requisite examination fees for term-end-annual examination each year in due time as per notification given by the Controller of Examinations, failing which, a student shall not be eligible to sit for the examination.
- 9.7 However, in some special cases, relaxation may be made by the **competent authority** as per the merit of the case.
- 9.8 Online Admit card required for the examination will be available after submission of examination form and requisite fees as per notification given by Controller of Examinations and subject to fulfilment of eligibility criteria to appear in the University Examinations.
- 9.9 A candidate who satisfies the requirement of attendance (80% theory and 100% practical), internal assessment marks, as stipulated by the University shall be eligible to appear for the University Examination.
- 9.10 Candidate should score a minimum of 50% marks in theory and practical separately in each subject for university examination.
- 9.11 The minimum pass marks for internal assessment is 50% and for the University examination is 50%.
- 9.12 If a candidate fails in either theory or practical paper, he/she has to re-appear for both the papers (theory and practical) as backlog.
- 9.13 If the candidate fails to secure 50% in theory and practical separately then he/she has to reappear for both theory and practical. The candidate if fails can be permitted for admission to the next year however he/she will be given chances to clear the backlog subject. If the candidate fails in that attempt then he/she must reappear those backlog papers again with the regular exam of the following year. Therefore the candidate must clear all his/her previous examination subjects before appearing for the 4th year final exam.
- 9.14 Institution shall not submit average internal marks of the test students more than 75% i.e., if 40 students are admitted in course, the average score of the 40 students shall not exceed 75% of total internal marks.(Example of 5 students; A=25, B=20, C=22, D=21, E=24. Average score= 89.6%. This will not be accepted by the State Nursing Registration Council).
- 9.15 The maximum period to complete the programme shall not exceed 8 years. i.e. The tenure of the programme is 8 years.
- 9.16 All practical examinations should be conducted in the respective clinical areas.
- 9.17 Number of candidates for practical examination should be maximum 20 per day.
- 9.18 One internal and external examiner should jointly conduct the practical examination for each student.
- 9.19 An examiner in the nursing subject should be an Assistant Professor/<u>Senior Lecturer</u> or above in a College of Nursing with M.Sc. Nursing in the concerned subject and must have minimum of three years of teaching experience. Year of experience may be considered in extreme cases for internal examiner.
- 9.20 To be an examiner in Foundations of Nursing, M.Sc. faculty in any specialty with three years of teaching shall be considered.

Note:

- i) Anatomy and Physiology Question paper will consist of Section A Anatomy 37 marks and Section B Physiology should be of 38 marks.
- ii) Nutrition and Biochemistry question paper will consist of Section A- Nutrition 45 marks and Section B Biochemistry 30 marks.
- iii) Pharmacology, genetics, pathology: Section A- pharmacology with 38 marks, Section B of Pathology 25 marks and Genetics- 12 marks.
- iv) Nursing Research & Statistics : Nursing Research- 50 marks and Statistics -25 marks.

- v) Minimum pass marks shall be 40% for English only.
- vi) Theory and Practical exams for Computer subject shall be conducted as College Exam and marks to be sent to the University for inclusion in the mark sheet.
- vii)Grace marks and re-evaluation is not permitted in any Course/ Paper. However, re-checking/review of the papers may be allowed if a candidate desires.
- viii) Question paper, Answer script, Attendance sheet of each course to be preserved as per university policy.
- ix) Details of the rules for examination to be followed by the students are mentioned in **Annexure-I** at the end of the curriculum.
- x) Theory papers shall consists of long questions of 15 marks having sub-divisions and short notes with a weightage of 5 marks. For Practical papers, the entire paper shall have two main parts Procedure and Viva-voce

10. FORMATION OF BOS SUBJECT- WISE

- **10.1.** There shall be subject wise board of study (BOS) committees which will be presided over by the Secretary for each committee.
- **10.2.** Each BOS shall comprise of four to five members consisting of both external and internal members.
- 10.3. Preferably Subject teacher / Eligible faculty members will submit course/paper wise question bank consisting of 150 no of very short answer type questions, 50 no of Short answer type questions and 30 no of Long answer type questions in a sealed envelope signed by the internal paper setter or through software to the examination department.
- 10.4. <u>The subject coordinator shall also conduct the continuous/internal assessment (theory and practical)</u> <u>from time to time.</u>

11. Paper setter, Moderator, Examiner, Scrutinizers:

- 11.1. As question bank will be used to prepare final question paper through moderation in term-end annual examinations. Thus there is no need of separate paper setter. Question bank will be submitted by the respective subject teacher or BOS members of the subject as per University rules.
- 11.2. Examiner shall comprise of two members one internal and one external. (An examiner should be an Assistant Professor or above position in a College of Nursing with M.Sc. Nursing qualification in respective Course/ Paper and minimum of 3 years of teaching experience after obtaining postgraduate nursing qualification at Collegiate/ University level.)
- 11.3. <u>Moderator shall comprise of two members one internal and one external. (A moderator should be an</u> <u>Associate Professor / Reader or in above position in a College of Nursing with M.Sc. Nursing</u> <u>qualification in respective Course/ Paper and minimum of 5 years of teaching experience after</u> <u>obtaining postgraduate nursing qualification at Collegiate/ University level.). Experience may be</u> <u>considered in extreme cases for internal moderator.</u>
- 11.4. External examiners may be appointed for conducting the practical paper /course in the practical term-end annual examinations.
- 11.5. Honorarium will be paid to the examiners, scrutineers, reviewers and moderators as per University rules.
- 11.6. Moderated question papers will be handed over to the Controller of Examinations for printing, preservation and distribution, by the respective Chairperson of BOS.
- 11.7. Distribution of answer scripts to the concerned examiners for evaluation will be done by the Department of Controller of Examinations and the examiners will be bound for discharge their duties as per relevant provisions of the statue/rules of the state Govt. After evaluation, the award lists in sealed packet must be sent

by the Head Examiner/examiner within stipulated time to the Controller of Examinations for timely publication of results.

11.8. Preferably Chairperson of BOS will act as head examiner of the respective department.

12. Scrutiny of Answer Script :

By default Post evaluation Scrutiny before result declaration of all theoretical answer scripts shall be done by the teachers of any discipline appointed by the controller of examinations as scrutineer recommended by BOS of respective department.

There shall be no scrutiny for practical papers.

A teacher who is the examiner of a concerned paper shall not be the scrutinizer of the same paper.

A. Scrutineer will check the following:

- (a) There is no mistake in the grand total on the title page of the answer script.
- (b) All marks have been correctly brought forward on the title page of the answer script.
- (c) No portion of any answer has been left un-evaluated.
- 13. **<u>REVIEW</u>**: A student can apply for review of the results on regular theory papers only as per notification given from Controller of Examinations after publication of results. Backlog theory papers are not entitled for review.
- Candidates applying for review, are not eligible for Post Publication View of the same paper.
- The university will release an online application form for 'Review' within 10 to 15 days of publication of annual exam results, following which the students shall fill and submit the online application form according to notification given by controller of Examinations.
- The results of review shall be published as per the university regulations.
- Review fees shall be Rs. 2000/- (two thousand rupees only) per paper/course but that is subject to change from time to time as per university policies.

The selected Reviewer will check the following:

- (a) There is no mistake in the grand total on the title page of the answer script
- (b) All marks have been correctly brought forward on the title page of the answer script

(c) No portion of any answer has been left un-evaluated

(d) If the Reviewer has noted that apart from the above some gross mistake in evaluating the answer scripts, he/she may take necessary steps to rectify the same.

(e) <u>Name of two reviewer shall be recommended from the respective department.</u> From which Principal nursing will select any one, who will be appointed for reviewing the answer script. In case of difference exceeding 10 marks, the second reviewer shall be appointed whose decision shall be final.

(f) The marks awarded by the reviewer shall be the final one. The marks may increase/decrease/remain unchanged after the review.

(g) Original Grade card/Report card of the examination for review candidates will not be issued. They will get Original Grade card after review.

(h) There shall be one reviewer per paper who may be internal and/or external examiner.

14. **POST PUBLICATION VIEW (PPV) :**

- 14.1. Photocopy of evaluated answer scripts of recently concluded examinations may be obtained by an examinee concerned once only for self-inspection on submission of application of Post Publication View to the Controller of Examinations of the University in prescribed format (available in https://www.brainwareuniversity.ac.in/downloadforms.php) on payment of https://www.brainwareuniversity.ac.in/downloadforms.php) on the payment of <a href="https://www.brainwareuniversity.ac.in/downl
- 14.2. The examinees shall have to appear with original Registration card, Grade card and admit card for the concerned examination on the specified date and time as may be intimated by the university through notification to view the photocopy of answer scripts preferably within 3 weeks from the last date of submission of such application. Failing which candidate may not be entertained further.
- 14.3. Application for photocopy of answer scripts for the purpose of self-inspection is to be submitted within 3 weeks from the date of publication of result of the concerned examination. Application proforma and details are available at the University website.
- 14.4. Post publication view does not mean reassessment or re-evaluation of the answer scripts. Photocopy of answer scripts will be provided to the candidate in presence of examiner to see the following:(a) There is no mistake in the grand total on the title page of the answer script
 - (b) All totals have been correctly brought forward on the title page of the answer script.
 - (c) No portion of any answer has been left un-evaluated.
 - Any other representation excepting the above three points shall not be admissible.
- 14.5. In the event of detection of any omission or mistake in the script or in the compilation of the result of a student, the matter shall be reported to the Controller of Examinations, who will take necessary measures for correcting the result accordingly and revised grade card shall be issued after the previous grade card is surrendered.
- 14.6. If any such student refuses to surrender his previous grade card/report cards shall be treated to have misbehaved and shall be dealt with by the Examination Disciplinary Committee under the relevant provisions of these regulations.
- 14.7. The Vice Chancellor shall have the power to recover such Grade Cards/report cards. through the law enforcing agencies of the state.
- 14.8. The University shall not entertain any claim for redressal of grievance of the concerned examinee arising out of self-inspection relating to evaluation of answer scripts.
- **15.** <u>Backlog Examination</u>: If any candidate fails to secure pass marks or fails to attend internal assessment and/or external term-end-annual examinations of any paper/course, then that paper/course will be treated as a backlog paper. Backlog Examinations will be conducted in the month of March of every year. Beside that a candidate may appear backlog examinations at regular Term-end annual examinations in the month of September of every year. Therefore in every six month backlog examinations will be conducted. Candidate shall appear his/her backlog papers accordingly during the tenure of the programme. Such candidates have to submit backlog Examination form and requisite

fees as and when notified by the Controller of Examination to appear in the examinations. Backlog candidates have to re-appear the internal assessment as well external assessment of that paper.

16. <u>Special Examination</u>: If any candidate fails to secure pass marks or fails to appear in final year theory & practical papers only, he/she can undertake Special examination, which will be held only for final year within a reasonable time period after publication of the result of the final year. A student is eligible for Special Examinations provided he/she does not have any Backlog paper in previous years.

Special exam will be conducted only once in a year after the declaration of Final year result tentatively in the month of January.

17. <u>Preservation of Theory & Practical answer scripts</u>: The written answer scripts of each External term-endannual examination will be preserved in the University for **06** (**Six**) months only from the date of publication of that result of the said term-end-annual examination. The answer scripts of the class test or other records of internal assessment shall, however, be preserved in the department for six (06) months from the publication of that result of the said term-end-annual examination. After that period, the scripts may be disposed off or send for recycling as per rules of the University.

18. DECLARATION OF CLASS IN FINAL YEAR RESULT:

A successful candidate obtaining 75% and more marks in the grand total aggregate of all years shall be declared to have passed with **First Class with Distinction**.

A successful candidate obtaining 60% and more but less than 75% of marks in the grand total aggregate of all years shall be declared to have passed with **First Class.**

A successful candidate obtaining 50% and more but less than 60% of marks in the grand total aggregate of all years shall be declared to have passed with **Second Class**.

Year wise rank list of pass out students will be declared on the basis of the aggregate marks obtained by a candidate in the University Examination. Only those candidates who have passed all the subjects in all examinations within 4 years according to programme duration, they shall be eligible for the award of **Rank**.

Meritorious candidates will be awarded medals as per Institute Policy.

20. Marks Statement:

Based on the marks earned, a marks card shall be issued to all the registered students after every year. The marks card will display the course details (code, title, full marks, marks secured) along with actual percentage secured. Ranking of a student will be assessed upon the **actual percentage secured**.

Online Marks statement is issued to the candidates at the time of result publication. Original hardcopy Marks statement is also issued to the candidate generally after two weeks of publishing the result. Accordingly students are notified to collect the same from the administration office.

21. Degree Certificate:

To obtain the Degree Certificate for the programme which the student executed his/her study, he/she would have to clear all the papers. Online Provisional Certificate is issued to the candidate immediately after successful completion of the programme.

The original hardcopy Degree Certificates will be issued to the eligible candidates by the University at the time of Convocation on fulfillment of the conditions stated in the Rules & Regulations of the University.

22. Convocation:

The Convocation of the University shall be held annually as per the Convocation Regulations of the University. The University shall announce the date for the Convocation and call for applications from eligible students to register for the Convocation. The duly completed application form along with the prescribed Convocation Fee must be submitted by the student to the University within the specified date announced by the University.

Degrees shall be awarded in person at the Convocation for the students who have graduated during the preceding Academic Year. Degrees shall be awarded in absentia to such students who are unable to attend the Convocation.

23. Issue of Degree certificate Before the Convocation

In exceptional circumstances where a student requires the Degree Certificate before the date of the Convocation, for purposes of higher education or employment where the concerned University/Organization where the concerned student has secured/seeking admission/employment requires that the concerned student must produce the Degree Certificate, the concerned student may submit an application to the Controller of Examinations, University, along

with the prescribed Fee (INR. 500) and all the supporting documents (self-attested photocopy of Aadhar card, grade card of all semesters/year, Provisional certificate, money receipt).

The Vice Chancellor shall consider the merit of the application and submit her/his recommendation to the Chancellor for the issue of the Degree Certificate, or otherwise. The decision of the Chancellor shall be final and binding. On the approval of the Chancellor, the Degree Certificate shall be issued to the concerned student.

The minimum time taken to process and issue the Degree Certificate shall be two (02) calendar months from the date of receipt of the request for the issue of the Degree Certificate.

24. Procedure for Applying for Duplicate Grade Card /Marksheet :

(The duplicate Grade Card / Marksheet is issued only if the original is lost or stolen)

- a) The application form must be signed by the candidate, and his / her name must be furnished as printed on the Registration Certificate original Grade Cards / Mark-sheets issued by Brainware University.
- b) In case of missing of Grade Card / Marksheet a copy of the letter acknowledged by the local Police Station, stating loss of the particular Grade Card(s) / Mark-sheet(s) is to be enclosed.
- c) Requisite fee is INR. 1000 (Rupees one thousand only) per Grade Card or Mark sheet.
- d) Xerox copy of the original grade card / mark-sheet should be attached.
- e) Duplicate Grade Cards / Mark-sheets may be collected by the candidate or duly authorised person, whose signature must be attested by the candidate in the letter of authorisation addressed to the Controller of Examinations, normally after minimum 15 working days from the date of receipt of the filled in application. The University however reserves the right not to issue any duplicate documents in case it is deemed to be not fit to issue the same.
- f) The documents shall not be delivered by post. It should be collected by the candidate or his/her authorised person. At the time of collecting such Grade Card(s) / Mark sheet(s), the money receipt against submission of requisite fees, Authorization letter, if the candidate cannot come by person, in proper form and photocopy of any authentic photo-identity of the candidate or authorized person, if applicable, are required to be submitted.
- g) The duplicate grade card /mark sheet will be prepared same as original one except the inscription of **'DUPLICATE'** on top of the duplicate mark sheet / grade card.
- h) Application form can be download from <u>https://www.brainwareuniversity.ac.in/downloadforms.php</u>.

25. <u>Issue of Transcripts:</u>

Transcripts, as and when necessary, will be provided to the pass out candidate. For which the candidate has to apply in the prescribed proforma with requisite fees @ INR 2500 (Rupees Two Thousand Five hundred only) + Postal charges extra (if required). Application proforma and details are available at the university website (<u>https://www.brainwareuniversity.ac.in/downloadforms.php</u>). Candidates may download the form and apply for the same to the Controller of Examinations, Brainware University.

26. Migration certificate:

Migration certificate is issued to the pass out candidate by the university. For which the candidate has to apply for the same in prescribed a proforma with requisite fees @ INR 800. The certificate is used when you change your board or university. Application proforma and details are available at the university website (<u>https://www.brainwareuniversity.ac.in/downloadforms.php</u>). Candidates may download the form and apply for the same to the Controller of Examinations, Brainware University.

28. Reported against (RA) students:

A student found guilty of misconduct/adopting unfair means including carrying or using mobile phones /electronics gadgets and/or any such behavior/actions which in the opinion of the university/institutional authority is objectionable, shall be liable to the disciplinary proceedings- the student shall be exempted for 6 months, 1 year or can be barred. The nature of such malpractices committed during the examinations is listed in the Annexure- I.

• He/She is found to be in possession inside the examination hall of any book, or page of any book, or scribbling, or written note, or typed sheet, that may have a bearing on the Course/ Paper in which he/she is appearing, irrespective of whether such book, or page of any book, or scribbling, or written note, or typed sheet is used or not, or

- He/She writes answer on another candidate's answer script or helps him/her in any other manner in writing answer on his/her own answer-script or helps him/her in any other manner in writing answer or tries to obtain from, or to render to, any other candidate or any other person inside or outside the examination hall, any help in any manner, or
- He/She leaves the examination hall without submitting answer-script, or
- He/She leaves the examination hall before one hour, taking with him/her answer-script, or carries from the examination hall the question paper during the hours of examination without submitting the answer script or gets possession of question papers outside the examination hall during the hours of examination or is not found in possession of complete question paper after its distribution in the examination hall or passes or tries to pass the question paper out of the examination hall or leaves the examination hall taking with him/her answer paper or loose sheet, or
- He/She allows somebody else to write answers on his/her behalf during examination, or
- He/She leaves the examination hall without recording his/her attendance on the attendance roll, or
- He/She encloses currency note(s) with an answer-script or offers illegal gratification or inducements to the Invigilator(s) or other persons connected with the examination or, in anyway, tries to take illegal or unfair advantages, or
- He/She distorts his/her name, roll number or registration number in his/her answer-script, or
- He/She is found to be in possession of any question paper or any other paper containing relevant answer or answers written on it, or
- He/She indulges in any kind of misbehavior, or intimidates or attempts to assault, or intimidates an invigilator or any other person connected with the conduct of the examination either inside or outside the examination hall, or damages, or attempts to damage, articles or furniture, equipment, stationery or any other property or the venue or creates disturbances in the venue or refuses to comply with the instruction of the Invigilator regarding seating arrangements in the examination hall, or
